We recognize the link between climate, conservation and the health and well-being of all living things and we strive to initiate, support and implement projects that support this interconnection.



How We Carry Out Our Mission

- Provide expertise and guidance to decision-makers in government, business, non-profit, academia, and other stakeholders (based on our team's deep expertise in each of these sectors) on environmental policies that address the urgent need to take action;
- Partner with non-profit organizations and other key stakeholders on campaigns and initiatives that utilize bold tactics, including creative communications, litigation, and investor education/outreach (based on our experience with environmental litigation and celebrity empowerment/engagement, among other relevant skills);
- Advise emerging cleantech companies on sustainability and related issues; and
- Educate the public through speeches, op-eds, books, and blogs (including numerous widely published books and op-ed contributions to major online platforms and news outlets).

Thriving Climate Program Facilitating Climate Solutions

Our Thriving Climate Program is dedicated to the facilitation and implementation of solutions that contribute to the goal of reducing GHG emissions to net zero worldwide by 2050.

We bring expertise and project management skills to execute projects that address the urgency of the climate crisis - our projects are action oriented and solutions based.

The technology and know-how exist to transition to a low carbon economy and we believe that through a combination of strategies we can make significant, timely progress in this fight.

Put a Price on It!

- In 2019, 7GA launched a working group between California state and Chinese national government officials; UC Berkeley/UCLA and Tsinghua University academic partners; and key NGOs to draft a roadmap for aligning the carbon markets in both countries with the goal of attracting other markets and nations into a global price on carbon by 2025.
- 7GA believes the world cannot prevent global warming from exceeding 1.5 degrees C without that solution in place. In 2020, although the Covid crisis prevented us from continuing in-person meetings in both countries, we have continued to work on the roadmap and raising the necessary funding to support the academic research groups.
- This is the only initiative underway with the full engagement of the Chinese national government to build a global price on carbon, but we are now working to expand support for this strategy (especially in anticipation of a Biden administration and re-entry into the Paris climate agreement).
- One way we plan to build a wider constituency for carbon pricing is to launch the "Put A Price On It!" campaign in 2021 and to share the benefits of carbon pricing on our website (and on a dedicated online platform in the future) at https://7thgenerationadvisors.org/carbon-pricing/



Clean Energy Access Fund

- Our Clean Energy Access Fund (CEAF)was designed to bring clean and affordable energy systems to underserved and vulnerable communities around the world, especially in collaboration with First Nations and indigenous regions.
- The first project was implemented in Fiji with the creation of a trust fund, managed by the Fijian government and from which remote island communities can borrow funding to replace dirty diesel micro-grid generators with clean, renewable solar/battery systems, repaying the costs from fuel/maintenance savings.
- When loans are repaid, funding is made available to other communities.



Clean Energy Access Fund

- FIJI: Working with the Fiji national government, village leaders, and local contractors, our team has now evaluated 36 villages for replacing diesel with solar/battery generators and concluded that 20 qualify for CEAF financing. We have developed a financial model estimating a budget of \$9mUSD to convert 70+ villages (out of an estimated 403 total) and have begun to raise new philanthropic funding into the Trust Fund to meet this need. The \$9m would revolve to more villages throughout Fiji over time and thereby build approximately \$40m of projects.
- INDIA: Our partners in India helped 7GA identify the first demonstration sites on islands of Gujarat and 5 sites on lat at waste management facilities for the CEAF program. Worthere has been temporarily suspended due to strict lockdown measures by the government, but we hope to resume the project in a few months.
- ETHIOPIA: We are collaborating with Winrock and Tufts University to evaluate their field research on more than 11,000 diesel-powered water pumping systems (for farming and towns) and are now designing the first demonstration projects under the CEAF model. 7GA is also creating a consortium to raise a philanthropic Trust Fund (similar to Fiji) to finance these proof-of-concept projects.

















Clean Energy Access Fund

- USA: We have entered into a partnership with the non-profit Dairy Farmers of America to develop a business plan for replacing coal-fired grid power with solar/batteries at a milk processing plant in PA and will help them raise PRI-type financing to build out the project. If successful, there are 47 such plants in the US and we will help DFA model the CEAF financing concept for all of them.
- CEAF COALITION: To accelerate progress and to more rapidly share "lessons learned" 7GA has created a Clean Energy Access Fund Coalition comprised of partners on projects to date and prospective developers, local authorities, and finance/donor sources. The purpose of the Coalition will be to provide technical assistance to communities seeking clean energy solutions and financing in order to develop more "shovel ready" projects in each region and to harness local expertise and support.



R20 Project Sourcing

- 7GA helped the R20 Regions of Climate Action design a new \$750m investment fund for climate infrastructure in developing nations that has attracted a \$150m commitment from the UN Green Climate Fund "GCF" as junior "first loss" capital into a blended finance vehicle (reducing risk and increasing ROI for conventional investors). - We have already sourced over \$200m of waste and renewable energy projects in India, Brazil, and Asia and will help source and diligence additional projects for the Fund when it opens for business in Q1 2021.
- 7GA has been asked to serve as the manager of the environmental and social management system to ensure alignment with UN SGGs and other best practices.



























Thriving Waters, Lands and Wildlife Health for the Whole Earth

Our Thriving Lands, Waters and Wildlife program is designed to fill in gaps and provide resources for efforts to protect threatened ecosystems, recognizing the link between climate; conservation; and the health and well-being of all living things.

We seek out and implement bold, novel ideas and solutions that can be replicated and leveraged in order to make greater impact before "points of no return" are reached for species and the climate.

From litigation to advocacy and education we strive to contribute to the goal of ending the extinction crisis and protecting our wild lands and waters to support the collective health of the Whole Earth.

Thriving Waters, Lands and Wildlife Program

Environmental Law Enforcement

- Under the US federal Clean Water Act and other environmental protection statutes, citizens are encouraged to identify sources of pollution and back up limited government enforcement efforts in their region.
- 7GA continues to advise numerous NGOs and foundations in their strategies and fundraising for "revolving" litigation funds.
- Five cases settled or were won in 2020 and returned over \$250k to these funds.



Thriving Waters, Lands and Wildlife Program

Protecting Our Waters

- 7GA has compiled a database of multi-benefit costeffective stormwater management project examples to help more cities adapt these beneficial projects and find innovative ways to finance them.
- Our team has also engaged 20+ cities to use the database and model their programs on proven success stories.
- Projects highlighted are designed to improve water quality, reduce local pollution, and increase local water supplies, including the location of the project, websites we sourced, project description, project benefits, and how the project was funded in these categories:
 - Water Storage (Infiltration, Detention or Retention)
 - New or Improved Drainage Infrastructure
 - Flood Mitigation
 - Biofiltration/Green Infrastructure Elements (Green Streets, Bioswales, Raingardens, Permeable
 - Pavement, Energy Dissipator)
 - Habitat Restoration

Educating the Future

Our Thriving Communities program is centered around the ancient First Nations belief that the decisions we make today should result in a sustainable world seven generations into the future.

To accomplish this idea, we work closely with and learn from our First Nation's partners, then help to share and apply their knowledge and wisdom to modern day problems. This knowledge directly links to the work we do on environmental education.

Through this program we provide guidance to help build environmental literacy in public schools and for the public at large that is based on the idea of creating a sustainable world into the future.

First Nations Collaboration

- SGA engages with the <u>Wishtoyo</u>
 <u>Chumash Foundation</u> in its efforts to protect, restore, and communicate Native American cultural heritage in California and beyond.
- Our team serves on boards and advisory committees for Wishtoyo, helping them build the Chumash Village and protect their ancient tribal rights on the Utom River.
- SGA also works closely with the <u>Black</u>
 <u>Mesa Trust</u> of the Hopi people who are
 fighting to restore and protect their
 water sources.



Personal Climate Action Center

- In addition to our ongoing work to expand implementation of California's Environmental Education Initiative law (advising curriculum committees and teacher training efforts), 7GA launched a Personal Climate Action Center designed to inspire and empower individuals to take personal action to make reduce our impact on the planet.
- We researched the work of other organizations —
 everything from calculators to offsets - and have
 begun putting this information all in one place to
 create a trusted, effective "one-stop shop" to help
 individuals and small business to achieve climate
 action goals.
- In addition we have launched a public outreach campaign to our over 12,000 subscribers encouraging them to take one action per week through our "Tip of the Week" email campaign.

Eco-Literacy

- To get lasting and large-scale change in America and beyond, we need to go directly to the source of future decision makers: our students in public schools. We believe students who are environmentally literate will make informed decisions as consumers and voters, be better stewards of their own environment, and will be equipped to take advantage of green job opportunities.
- To achieve this, the State of California's Department of Education (CDE) and our partner Ten Strands are implementing a model pilot program for leveraged change and capacity building in California to influence more than 350,000 public school students in grades K to 12, implementing the state's Environmental Education Initiative law (drafted by SGA's Leslie Tamminen in 2001) as part of regular instruction in science, history- social science, English language arts, and other core subjects.
- Efforts like this showcase California as a model for investing in and spreading environmental literacy. SGA is now working with the government of Chile to model their new eco-literacy programs along California's example.






Special Purpose Funds 7GA is working with a number of groups by housing Special Purpose Funds working on a range of issue areas.

Special Purpose Funds

Chimpanzees in Need – Wildlife Waystation

- In late 2019, the California Department of Fish and Wildlife (CDFW), asked SGA to establish a Special Purpose Fund to support the animals at southern California's Wildlife Waystation. After 40 years of caring for abandoned and surrendered exotic and domestic animals, the Wildlife Waystation closed its doors in early 2019. The fund helps offset the costs for vital veterinary care, feeding and housing for the wild animals that are still at the Wildlife Waystation.
- With the aid of CDFW nearly half of the 500 animals at the Waystation have found homes at other sanctuaries, including grizzly bears, black bears, African lions, tigers, bison, hyenas, primates, exotic small cats, birds, reptiles and horses. But the remaining animals including 39 chimpanzees that will need to be kept together in a number of family units are still in critical need of help.
- We have successfully raised over \$300k to feed and maintain these chimps and to ultimately fund their relocation to accredited sanctuaries in other states. https://primatesanctuaries.org/chimps-in-need/



Special Purpose Funds

Utom River Special Purpose Fund

- 7GA's inspiration comes from First Nations values and wisdom. We support the work of indigenous communities in many ways, but in 2020 one highlight was our UTOM River Donor Advised Fund (DAF).
- We established this Special purpose fund with settlement money from litigation to protect the Utom River (Santa Clara River in Ventura County) on behalf of plaintiffs Wishtoyo Foundation, Santa Ynez Band of Chumash Indians, CA Native Plant Society, and the Center for Biological Diversity.
- 7GA assists these groups in identifying threats to the river, opportunities to restore and protect it, and cultural values/assets along the river in need of conservation. We also manage the fund's investments to maximize sustainable growth to ensure long-term funding for its environmental and cultural goals.




Special Purpose Funds

Environmental Justice Resources



There is much to do, but to begin, we are committed to:


- Through our <u>Clean Energy Access Fund</u>, identifying and prioritizing projects that are in communities of color and viewing potential projects through a racial equity lens.




7GA Income 2020
